Welcome, apologies, declaration of interests and apologies

17 Matters actioned and matters arising

Executive Director of Corporate Governance, Claire Dunning, introduced the paper. Committee noted the items and made the following key points:

- i. The Committee terms of reference (TOR) had been updated to reflect the discussion held in the meeting that took place on 19 September 2023. Following discussion further revisions were agreed:
 - The Digital Plan should continue to be recommended to the Board for approval, and not be delegated to Committee (item 2b and 3d);
 - Reference to cash balances, investment performance and financial strategy should be moved from TOR1 to be distinct items in TOR2 and the phrase 'where appropriate' added to the first line of point 2

- Information requested at the last meeting on the number of University buildings that already had LED lighting installed had been circulated to Committee on 28 September 2023.
- iii. Committee had requested an update on the work of the Continuous Improvement group at this meeting. However, it was reported that the work of this group had been combined with the task and finish group looking at budget savings for 2023/2024 whose work was ongoing. Committee agreed that an update from the Head of Continuous Improvement should be brought ideally to the November 2023 meeting to report on the work conducted over the previous months.

18 Financial Memorandum of Understanding

Executive Director of Corporate Governance, Claire Dunning, introduced the Financial Memorandum which was produced in partial fulfilment of Section 22(1) of The Education Act 1994 which requires that: "The governing body [of the University] shall take such steps as are reasonably practicable to secure that any students' union at the establishment..... is accountable for its finances." It was noted that:

- i. The University and the Students' Union reviewed the document annually and had recommended some minor changes as outlined.
- ii. Several stakeholders were consulted including the Union trustees.
- iii. The Committee approved the changes ready for the document to be signed.

19 Annual Insurance Report

Anita Randell, Insurance Officer presented the paper. Key points noted were:

- To provide wide coverage and rating stability in the context of a continued hard market, the majority of insurance contracts were under long-term agreements until 2025 with an option to extend for a further 2 years.
